## Please read carefully:

Release of Liability, Assumption of Risk and Waiver of Claims Agreement relating to winding path inc. workshop or retreat (the "Workshop")

**To:** Winding Path Inc. and its shareholders, officers, directors, independent contractors, subcontractors, employees, and agents (hereinafter referred to as the "Releasees").

**Waiver**: In consideration of being permitted to participate in any or all activities of the Workshop, including, without limiting the generality of the foregoing, the low and high elements of the ropes course, hereinafter called the "Activities", I, for myself, my heirs, next of kin, personal representatives or assigns, do hereby covenant not to sue the Releasees and release, waive, and discharge the Releasees from all liability for injury, death, accidents, illness, property damage or any other loss sustained by me as a result of my participation in the Activities due to any cause whatsoever, including, without limiting the generality of the foregoing, breach of contract, negligence, or breach of any statutory or other duty of care by the Releasees.

Assumption of Risks: Participation in the Activities carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death. A component of this workshop is climbing. I understand that one does not have to climb high, or climb at all, to get value from the Activities. I understand that participants are encouraged not to climb if they have any physical limitations, and should not to go beyond their personal comfort levels. I understand that I have the choice to participate to at my own comfort level and it is not necessary to go beyond that level to get great value from the Activities. I certify that I am in suitable health and have suitable capacity to participate in the Activities. I have read all paragraphs herein and I know, understand, and appreciate these and other risks that are inherent in the Activities. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

**Indemnification and Hold Harmless**: I also agree to indemnify and hold the Releasees harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including legal costs and fees brought as a result of my involvement in the Activities and to reimburse them for any such expenses incurred.

**Severability:** The undersigned further expressly agrees that this agreement is intended to be as broad and inclusive as is permitted by the law of PEI and Canada and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
